1 RULES

The regatta will be governed by the rules as defined in
The Racing Rules of Sailing (RRS) 2017-2020.

2 ELIGIBILITY AND ENTRY

2.1 The regatta is open to boats of the Enterprise and GP 14 Classes under the control of members of clubs affiliated to the RYA

2.2 Eligible boats may enter by completing the appropriate entry form prior to racing on Saturday 10th June

3 FEES

3.1 Required fees are as follows:

6.1 The venue is Castle Semple Sailing Club, Lochlip Rd, Lochwinnoch, Renfrewshire, PA12 4EA.

6.2 The race area will be Castle Semple Loch.

7 THE COURSES

The courses to be sailed will be described in the sailing instructions.

8 SCORING

The event will be scored using Appendix A (*Low Point System*). Six (6) races are scheduled, of which three (3) races shall be completed to constitute a valid series. Each boat's series score will be the total of her race scores with her worst score discarded if four (4) or more races have been completed. Tie breaks as per Appendix A.

9 PRIZES

Prize giving will take place shortly after completion of racing on Sunday 11th

Competitors participate in the regatta entirely at their own risk. See rule 4, Decision to Race. The organizing authority will not accept any liability for material damage, personal injury or death sustained in conjunction with or prior to, during, or after the regatta.
